What Do I Need to Do to Get Started?

Matching a gift to BFCS only takes three easy steps:

- **STEP 1:** Contact your employee's human resources department to see if they offer a matching gift program.
- **STEP 2:** Obtain a matching gift form from your human resources department.
- **STEP 3:** Complete the form and send it in with your next gift to BFCS. BFCS will submit the form to your employer based on their matching policy.
